



APPLICATION FOR MEMBERSHIP TO THE PRIX ITALIA

(International Competition for Radio, Television Programs and Broadcasters' Web-Sites)

hereby requests that the Secretary General of the Prix Italia submit this application for Prix Italia membership to the General Assembly of the Members of the Prix Italia, pursuant to article 2 of the Prix Italia Statutes.

The applicant declares that it is familiar with, and accepts all the Statutes of the Prix Italia, including but not limited to, articles 2 and 14, which provide that:

Article 2 - *Only Radio or Television broadcasting organizations, duly authorized by competent authorities are eligible to be members of the Prix Italia. They must provide a national service, or, they must guarantee through syndication, the widest diffusion of the programmes throughout the country and assume a direct creative and financial responsibility for the programs they broadcast. If in any country several organizations of regional character are grouped together in one national association, then only that body may participate in the Prix Italia representing them all. Applications for membership can only be accepted by the General Assembly.*

Article 14 - *The membership of the Prix Italia requires the payment of an annual quota fixed each year for the following year by the General Assembly, after a proposal of the Secretariat. All member organizations are requested to pay their membership subscription fee within the first four months of the year to the bank indicated by the Secretariat, also if they decide not to send entries/or delegates to the Prix Italia. Organizations which have not paid the quota before the beginning of the session cannot appoint members of the juries or enter programs for their competition. Organizations which have not paid their quota for two consecutive sessions shall not be considered members of the Prix Italia.*

The annual fee has been set at Euro 1,400 for Radio Competition, at Euro 1,400 for Television Competition, and at Euro 600,00 for Web-Site Competition. The fees are reduced to Euro 500 for TV and Radio competitions, and to 300,00 for the Web, in the case of countries with a per capita GNP below US\$ 4,000 (according to the official United Nations figures).

The applicant organization undertakes to pay this annual membership fee no later than April 30th of each year.

The Prix Italia will be awarded in each of the below categories:

Radio Drama (2 prizes) Adapted Drama and Original Drama

Radio Documentary (2 prizes) no sub-categories.

One Prix Italia for overall quality

and one Prix Italia Special Prize for innovation and creativity

Radio Music (2 prizes) Musical Composition and Work about Music

Television Drama (2 prizes) Tv Movies and Miniseries, Series and Serials

Television Documentary (2 prizes) Cultural/General Interest and Current Affairs

Performing Arts (2 prizes) Performing Arts, Music and Arts Documentary
